

COVID19 Additional Requirements

- **Vienna, Austria – Site Code 4778**
 - Candidate must bring 2 FFP2 masks and must have proof of one of the following:
 - Negative COVID-19 test which is valid on test date. This may be either an antigen tests no older than 48 hours, or a PCR test no older than 72 hours.
 - COVID-19 vaccination
 - Recovered from COVID-19
 -
- **Peru, Lima – Site Code: 4794**
 - To test you will need to wear:
 - Double mask
 - Face shield
- **Germany, Frankfurt – Site Code: 4374**
 - Always wear a medical mask.
 - The site recommends that a COVID test is carried out 48 hours prior to the exam and a negative result to be presented in case there are any immediate changes due to government restrictions which can be enacted spontaneously.
- **Germany, Frankfurt – Site Code: 4695/4696**
 - Wear an FFP2-mask - even during the exam.
 - Written evidence of a negative COVID-19 test (PCR or antigen) that is not older than 48 hours.
 - The testing lab has an official COVID-19 test station that carries out PoC (antigen) tests 2 minutes walking distance from the testing center.
 - Free of costs quick-test appointments
 - The quick-test appointments can be booked for Monday to Friday for the time between 8.13 a.m. to 7.40 p.m. and for Saturdays for the time between 8.13 a.m. to 12.40 p.m.
 - The COVID-19 test station is closed on Sundays. You will receive the test result approx. 15-20 minutes after the test, as a PDF file by email.

- **Germany, Hamburg – Site Code: 4757**
 - Please wear an FFP-2, KN95 / N95 or surgical mask at all time.
 - COVID test needs to be conducted 24 hours/days before your CFA appointment from an official COVID testing station and a negative result needs to be presented.

- **Germany, Munich – Site Code: 4673**
 - Please wear an FFP-2, KN95 / N95 or surgical mask at all time.
 - It is preferred that a COVID test be conducted 24 hours/days before your CFA appointment from an official COVID testing station and a negative result needs to be presented.

- **Czech Republic, Prague – Site Code: 4822**
 - Negative PCR test - no later than 7 days ago
 - POC test for SARS CoV-2 antigen with a negative result no later than 72 hours ago
 - Issued certificate of the Ministry of Health of the Czech Republic for vaccination against COVID-19, and at least 14 days have elapsed since the second dose of the vaccine
 - People recovered from Coronavirus in last 90 days without any symptoms (proved by doctor's certificate)
- **Austria, Vienna – Site Code: 4778**

On test date, all candidates are required to show legally valid evidence of vaccination, a negative COVID-19 test, or having recently recovered from COVID-19. Candidate must also wear a face mask.

 - Proof of:
 - Self-test with digital solution: within 24 hours
 - Antigen test: within 48 hours
 - PCR test: within 72 hours
 - Testing exemptions for persons recovered or vaccinated:
 - Persons who were infected with Sars-Cov-2 will be exempt from mandatory testing for six months after recovery.
 - Vaccinated persons will also be exempt from mandatory testing. This exemption will apply for three months as of day 22, following initial vaccination and for nine months following second vaccination.
- **United Arab Emirates, Abu Dhabi – Site Code: 4585**
 - PCR Test results negative valid for 7 days

- COVID Card: either first dose or two doses (Full Vaccine).
- **Singapore, Singapore – Site Code: 4312**

Due to the Heightened Alert, from May 18 2021, Site is implementing the following Safe Management Procedures for everyone's safety.

- Candidates that have a temperature above 37.5 will not be admitted.
- Candidates taking a full-day test will be subject to 2 temperature checks (once at check-in, once after their lunch break).
- Masks must be properly worn at all times – fully covering nose and mouth.
- All candidates must use the Trace Together government app for admission.
