I understand and acknowledge that Prometric staff will not escort my child during exam breaks or upon completion, even if break or common areas or restrooms are located outside of the Test Center premises.

I hereby agree to release and hold harmless Prometric and its officers, directors, employees and agents from all damages, losses, or claims, whether to person, property or otherwise, arising due to my child's participation in an exam appointment on Prometric property, including but not limited to arrival and departure from the test center (whether accompanied by an adult guardian or not) and the duration of the test appointment including all scheduled and unscheduled breaks. ### Parental Release Form – 15 years of age and under

I understand and agree that it is my responsibility to accompany my child to and from the test center event location, and to be available throughout the testing period in the event that my child finishes early or needs to be escorted out of the testing room for a break. I understand that if I am unable to accompany and stay with my child throughout the test event that I must designate (below) an individual who is authorized and approved by me to accompany and stay with my child throughout the test event. I promise to accompany my child to the test center event, wait for him/her until testing is completed, and will be available to depart with my child when the test is completed. I understand that Prometric personnel cannot and will not assume responsibility for exam candidates who are minors that arrive at the testing event or leave the testing event without a guardian or designated caretaker.
